

Weed Control Foreman

JOB SUMMARY AND RESPONSIBILITIES: The foreman's primary role is to ensure that all weed control projects get completed on time and that the work of the field crew meets quality expectations. The weed control foreman is responsible for managing multiple projects at once and managing the weed control technicians' schedules and tasks. The foreman is expected to perform herbicide spot treatments on noxious weeds using ATV and backpack sprayers. Additional duties will include mechanical removal, mowing, and daily maintenance/repair of equipment and vehicles. Schedule flexibility is required to accommodate early morning starts, rain delays and wind delays. The workload for this position will be approximately 30-40 hr/wk, from May 15th – September 31st. The foreman will earn \$20.00 - \$24.00 per hour dependent upon experience plus a weekly gas stipend for commuting expenses to Driggs.
